**Public Hearing: Local Law Introductory No. A of 2025 –** Ms. Haskell reported there is a resolution for Legislature consideration to set the public hearing for January 23, 2025 at 10:00 a.m. at the Legislative Worksession.

**2025 Legislator Mileage Rate Change –** Ms. Haskell reported the County follows the IRS standard, which has increased to .70 cents per mile for 2025.

**Legislative Office Renovation -** The HVAC project is nearing completion. Discussion has occurred with Buildings & Grounds Supervisor for the installation of new carpeting, desks/countertops in the Legislative Office. County Administrator Bailey reported he would like to renovate the office with the installation of a door to increase the level of privacy and confidentiality for anyone who may be standing in the front office area. #### A NOTABLE YEAR FOR ELECTED & APPOINTED OFFICIALS

At the First Special & Organizational Meeting of 2024, the Legislature acknowledged and congratulated District #7 Legislator Flesher, Sheriff Howard, County Clerk Klett, Coroner Kline, and Coroner Williams on their new terms of office. All elected officials were sworn-in by County Clerk Klett.

Legislator/Chair Sauerbrey was appointed by the Legislature and sworn-in by County Clerk Klett to serve as the Chair of the Legislature for 2024 serving her eleventh one-year Chair term.

Legislator Monell was appointed by the Legislature and sworn-in by County Clerk Klett to serve as Deputy Chair of the Legislature for 2024 serving his second one-year Deputy Chair term.

Chair Sauerbrey was appointed as the County's Public Information Officer and Legislator Standinger was appointed as the Republican Majority Leader for 2024.

Sadly, the Legislature mourned the loss of one current and two former Legislators:

- **Legislator Dale N. Weston** passed away in office on April 2, 2024 and was posthumously recognized at the May 14, 2024 Legislature meeting. Legislator Weston was elected to the position of Tioga County District #6 Legislator on January 1, 2005 and successfully was re-elected every term thereafter.
- Former Legislator Todd E. Smith passed away on April 8, 2024 and was posthumously recognized at the May 14, 2024 Legislature meeting. Former Legislator Smith was elected to the position of Tioga County District #7 Legislator on January 1, 1999 and successfully re-elected until his resignation on September 30, 2003.
- Former Legislator Peter L. Ward passed away on May 8, 2024 and was posthumously recognized at the June 11, 2024 Legislature meeting. Former Legislator Ward was elected to the position of Tioga County District #7 Legislator on January 1, 1996 and successfully re-elected until he left office on December 31, 2004.

The Legislature convened twelve regular meetings, three special meetings, and eight public hearings in 2024. Minutes were recorded, typed, indexed, and copied for the official Journal of Proceedings.

The Legislature adopted 470 resolutions, including eight Recognition Resolutions.

The Legislature adopted the following policy revisions of the County's Employee Handbook; Comprehensive Information Security Policy, Personnel Rules, and Building & Vehicle Procedures.

The Legislature acknowledged twenty proclamations in 2024. Most notably were Employee Recognition, American Stroke Month, Great American Smokeout Day, Human Trafficking Awareness Month, Tioga Central Football and Waverly Central Football State Championships, Recognizing Tioga Central Football Coach Aiello on being Selected as the 2023 Lou Rettino High School Coach of the Year, Bell of Sessions/Emma Sedore Day, Salute to Tioga County Employee Veterans and Active Military Day, and Recognition of Centennial Year of the New York State Association of Counties.

The Chair of the Legislature presented the State of the County Address at the Fourth Regular Legislature Meeting on April 9, 2024.

The County Administrator presented the 2025 Tentative Budget at the public hearing on November 12, 2024.

The Legislature adopted the 2025 County Budget at the Twelfth Regular Legislature Meeting on December 10, 2024.

## COUNTY AUDITOR

The County Auditor provided monthly AP updates to the Legislature as part of the Legislative Support Committee report.

The County Auditor reviewed and processed 2,447 purchase card transactions totaling \$597,909.74, which is an increase of 492 transactions and \$67,828.20 from the previous year.

The County Auditor reviewed and processed 8,725 accounts payable invoices totaling \$25,826,582.49, which is a decrease of 406 invoices and \$523,568.70 from the previous year.

#### 2024 LOCAL LAWS

The Legislature introduced and adopted the following two (2) new Local Laws:

- Local Law No. 1 of the Year 2024 A Local Law authorizing twelve (12) and thirteen (13) year old licensed hunters to hunt deer with a firearm or crossbow during hunting season with the supervision of an adult licensed hunter. This local law was adopted on April 9, 2024 with an immediate effective date.
- Local Law No. 2 of the Year 2024 A Local Law Amending Local Law No. 1 of 1988 establishing a Schedule of Fees for permits issued by the Tioga County Department of Health as amended by Local Law No. 1 of 1990, as amended by Local Law No. 3 of 1991, as amended by Local Law No. 8 of 1995 and as amended by Local Law No. 3 of 2002. This local law was adopted on November 12, 2024 with an effective date of January 1, 2025.

#### **PERSONNEL**

The Legislature appointed Jackson D. Bailey, II as the new County Administrator effective July 1, 2024.

The Deputy Legislative Clerk position became vacant on August 2, 2024 due to a resignation.

#### STATE OF EMERGENCY

Chair Sauerbrey, in agreement with the Tioga County Legislature, continued the State of Emergency originally issued on November 8, 2023 throughout 2024 regarding the prohibition of accepting New York City FHEPS and/or SOTA housing vouchers within Tioga County without prior written approval.

On October 31, 2024, Chair Sauerbrey issued a State of Emergency Burn Ban prohibiting outside burning of any type due to the lack of rain and dry conditions, making conditions at an increased risk of fires. The State of Emergency Burn Ban was rescinded as of November 29, 2024.

RESOLUTION NO. -25 ADOPT LOCAL LAW NO. 1 OF 2025

WHEREAS: A public hearing was held on January 23, 2025, following due notice thereof to consider the adoption of Local Law Introductory No. A of 2025; a Local Law establishing the salary for the Office of County Treasurer for the term of office set forth by New York State legislation commencing on January 1, 2026; and

WHEREAS: It is in the best interest of the residents of Tioga County to adopt such Local Law which will be Local Law No. 1 of 2025; therefore be it

RESOLVED: That the following Local Law be and hereby is adopted:

County of Tioga County

Local Law No. 1 of the Year 2025.

A Local Law establishing the salary for the Office of County Treasurer for the term of office set forth by New York State legislation commencing on January 1, 2026

Be It Enacted by the Legislature of the County of Tioga as follows:

SECTION 1: PURPOSE

As set forth in Local Law No. 3 of 2003, the annual salary for the elected public office of County Treasurer shall not be increased during a term of office.

Accordingly, it is the purpose and intent of this Local Law to establish the salary for Office of County Treasurer for the term of office set forth by New York State legislation commencing on January 1, 2026.

SECTION 2: ANNUAL SALARY

- A) The annual salary for the Office of County Treasurer for the term of office set forth by New York State legislation commencing January 1, 2026 is hereby established as follows:
  - 1. County Treasurer

\$82,023

#### **SECTION 3: SEVERABILITY**

If any clause, sentence, phrase, paragraph, subdivision, section, rule or part of this ordinance shall be adjudged by any Court or Agency of competent jurisdiction to be invalid, such judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, phrase, paragraph, subdivision, section, rule or part thereof directly involved in the controversy in which such judgment shall have been rendered.

#### SECTION 4: EFFECTIVE DATE

This Local law shall take effect January 1, 2026.

WHEREAS: The County of Tioga presently has State Legislation authority to collect an additional 1% sales tax, but said authority expires as of November 30, 2025; and

WHEREAS: Tioga County is requesting State Home Rule Legislation for another two-year extension of the 1% sales tax through November 30, 2027; therefore be it

RESOLVED: That the Tioga County Legislature hereby requests our State Legislators, Assemblyman Christopher S. Friend and Senator Thomas F. O'Mara, to prepare a Home Rule Statute giving the County of Tioga authority to extend the additional 1% sales tax from November 30, 2025 to November 30, 2027, or the maximum time permissible.
