

Brief Description of Proposed Action: This project involves an update of the Tioga County IDA's e=mt3 Mixed Use Office Park Project, for which an EIS was completed in 2006. This ESite Master Plan Update includes an update of more realistic uses on this site based on market activity and interest in the past decade, plus options for updated site layout. This update includes mainly residential uses in the forms of multi-family apartments and townhouses, and a small general office building. There will no longer be light industrial or flex-tech structures, or health care facilities due to existence of jurisdictional USACE wetlands. Minimal wetland impacts from proposed development will be mitigated as prescribed by USACE.
